



Environmental Stewardship Award

Purpose:

To recognize outstanding environmental stewardship efforts by Farm Bureau Young Farmers and to increase public awareness of the agricultural community's commitment to environmental stewardship by publicizing winners' accomplishments, while encouraging environmental preservation and best management practices on farms.

Eligibility:

Young Farmers who

- were nominated by anyone interested in recognizing Young Farmers using an approved nomination form (competitors cannot nominate themselves)
- are Farm Bureau members in good standing with their county Farm Bureau and between the ages of 18 and 35 years. (full-time or part-time farmers are included)
- have evaluated the potential environmental & wildlife effects of practices, structures and conditions on their farm.
- have a plan to deal with significant environmental/conservation problems and opportunities.
- have shown significant progress in implementing their plan over two to four years or longer.
- submit a completed Environmental Stewardship application by March 31st.

Procedure:

Nominations must be sent by February 28th to Virginia Farm Bureau (VFB), Attn: W&YF Dept., P. O. Box 27552, Richmond, VA 23261 or e-mailed to ron.saacke@vafb.com. Nominees will receive a certificate and a letter stating who nominated them, along with a copy of the full application and requirements.

Nominees can use any of their local resources for help in filling out the application including: County Extension Service, Farm Service Agency, Soil and Water Conservation District, agribusiness consultants, etc. .

The state winner will receive an expense paid trip to join in the Young Farmers and be recognized during the Awards Breakfast at the VFB Convention in November.

Awards:

District winners will be presented with a Young Farmer Environmental Stewardship sign suitable for outdoor display at the farm entrance or similar location and a trip to the VFB Young Farmers Winter Expo in January. The state winner will also receive a cash award and a personalized plaque to commemorate their award.
